Detailed Terms of Reference (TOR) for Expression of Interest (EOI) to facilitate the sale of furniture items to Government Departments and Public Sector Undertakings

H.P. State Forest Development Corporation Limited (hereinafter referred to as "HPSFDCL") a Government of Himachal Pradesh undertaking engaged primarily in the marketing and sale of timber, forest produce, and other related products, invites Expressions of Interest (EOI) from experienced and qualified firms/agencies (hereinafter referred to as "Applicants") for facilitating expeditious and efficient sales and distribution of the furniture products etc. amongst the Government Department and Public Sector Undertakings.

#### 1. Introduction:

The H.P. State Forest Development Corporation Limited (HPSFDCL), a Government of Himachal Pradesh undertaking, is seeking to establish a channel partner in the State of Himachal Pradesh to facilitate expeditious and efficient sales and distribution of furniture products to government departments and public sector undertakings. To achieve this, HPSFDCL is issuing an Expression of Interest (EOI) to identify experienced and qualified firms/agencies. This document outlines the Detailed Terms of Reference (TOR) for this EOI, inviting applications from entities capable of facilitating the efficient and expeditious sale and distribution of these furniture items.

### 2. Eligibility Criteria:

Sealed applications will be accepted only from reputable furniture manufacturing firms or their authorized dealers. The applicant must be a company registered under the Companies Act or an authorized dealer of such registered Company, in India, and must have been in continuous operation for a minimum of five years.

## 3. Financial Capacity:

The applicant must have an annual turnover of at least INR 15 crore (Fifteen crore) for the preceding three financial years. Audited financial statements for these years must be submitted as proof.

## 4. Local Presence and Service:

The applicant must have either its own or an authorized wholesale dealer or service office within Himachal Pradesh, operating continuously for the past five years. Proof of this operational presence is required.

#### 5. Experience:

- The applicant must provide evidence of having successfully completed at least three similar orders for the supply of furniture to government departments within the state of Himachal Pradesh during the past five years.
- ii. The applicant must submit an affidavit on non-judicial stamp paper, duly notarized, declaring that the firm has not been debarred or blacklisted by any government, semi-

government, public sector undertaking (PSU), board, university, or autonomous body in India during the past five years.

#### 6. Quality Standards:

The applicant must possess and provide valid certificates demonstrating compliance with all relevant quality and safety standards as specified in the bidder's checklist.

#### 7. Environmental Considerations:

Preference will be given to firms engaged in manufacturing of environment friendly green furniture, provided all other criteria are met. Supporting documentation regarding environmental certifications and practices must be submitted.

#### 8. Price Integrity:

The applicant shall provide a legally binding undertaking that it will not sell furniture items (under the agreed discount percentage with HPSFDC) to any organization within Himachal Pradesh at a rate lower than that offered to HPSFDC. Any breach of this undertaking will result in the immediate termination of the agreement, as determined by the Managing Director of HPSFDC, and may incur penalties.

#### 9. Discount Offer Submission:

- i. The applicant shall submit its percentage discount offer in a separate, sealed envelope clearly marked 'Discount Offer (D)'. Sealed envelopes will only be opened and evaluated for firms that have been shortlisted.
- ii. The firms shall quote their percentage discount on their current listed price.
- iii. The applicant must submit copies of GST returns for the preceding three financial years.
- iv. The applicant must submit all required documents as specified in the bidder's checklist and these TOR. Failure to provide all required documents will result in disqualification.

#### 10. Affidavit:

The applicant must submit an affidavit on non-judicial stamp paper, duly notarized, declaring that all information provided in the submitted documents is true, accurate, and complete. Shortlisted applicants will be required to enter into a formal agreement with HPSFDC, outlining the terms and conditions of payment and other contractual obligations.

#### 11. Dispute Resolution:

Any dispute arising from the agreement to be subsequently signed with the selected firms shall be subject to the exclusive jurisdiction of the courts located within Shimla, Himachal Pradesh.

#### 12. Price List:

The applicant's prevailing published price list will be applicable and binding on HPSFDC. The applicant shall grant HPSFDC a percentage discount based on the price list of furniture and related items.

#### 13. Taxes and Duties:

Applicable GST and other taxes will be charged extra as per prevailing regulations.

#### 14. Timeline:

- ii. The EOI will be opened on the same day at 03:00 PM in the presence of the attending representatives (if any).

## 15. Contract Termination and Penalties:

The agreement shall be terminated by the HPSFDCL if the firm fails to adhere to the terms and conditions of the contract, fails to supply goods within the agreed timeframe, or supplies substandard goods. In such cases, penalties, including but not limited to financial penalties and forfeiture of performance security, will be imposed as determined by the MD HPSFDC. HPSFDC also reserves the right to pursue legal remedies for damages.

#### 16. General Conditions:

- HPSFDC reserves the right to reject any or all bids without assigning any reason whatsoever.
- The number of firms to be selected and the minimum acceptable discount will be at the sole discretion of the MD of HPSFDC.
- iii. By submitting a bid, the applicant acknowledges and accepts all the terms and conditions outlined in these TOR.
- iv. The HPSFDCL reserves the right to modify or cancel the EOI process at any time.

  v. This EOI does not constitute a binding offer The Amount of the EOI process at any time.
- v. This EOI does not constitute a binding offer. The HPSFDCL reserves the right to modify or amend the terms and conditions of this EOI at any time
- vi. Incomplete, late, or non-compliant submissions will not be considered.
- vii. All costs associated with the preparation and submission of EOIs shall be borne by the Bidders.
